WHAT IS ARPA?

AMERICAN RESCUE PLAN ACT (ARPA) FUNDS

In order to rebound and rebuild after the COVID-19 crises, communities across the nation were provided with funds under the American Rescue Plan Act signed into law in 2021. The Town of Southport received two payments of ARPA funds totaling a little over \$1,000,000. These funds were used for a variety of purposes with the goal of enhancing the Town's assets for the future. The investments represent upgrades, repairs, and new or used purchases for our buildings, parks, and cemeteries. Per the legislation, ARPA funds needed to be fully committed by December 31, 2024 and spent by December 31, 2026. Below is a listing of these investments.

HISTORICAL SOCIETY

ONE OF SOUTHPORT'S "OWN" CLARA RUTH COOK – CALLED "BABE"

CLARA RUTH COOK, CALLED "BABE" BECAUSE SHE WAS THE YOUNGEST OF 11 CHILDREN. CLARA'S PARENTS WERE JOHN AND CLARA COOK OF PINE CITY, NY A FEW RELATIVES RESIDE IN THE SOUTHPORT AREA TODAY. CLARA ATTENDED PINE CITY SCHOOL AND SOUTHSIDE HIGH SCHOOL.

CLARA LOVED PLAYING BASEBALL AND ONE DAY A MAN EMPLOYED BY REMINGTON RAND NOTICED HER BASEBALL SKILLS AND ASKED HER PARENTS TO ALLOW HER TO PLAY FOR THE RAND'S BASEBALL TEAM. CLARA'S PARENTS AGREED AND CLARA KNEW THIS WAS A WONDERFUL OPPORTUNITY.

AT AGE 13, CLARA BEGAN PLAYING BASEBALL FOR THE RAND, AND CONTINUED THROUGH HER TEENS. AFTER GRADUATING FROM SOUTHSIDE HIGH SCHOOL, SHE WENT TO WORK FOR THE RAND AND SHE ALSO HELPED ORGANIZE FRIENDS TO PLAY BALL FOR THE COMPANY.



BORN: JUNE 19, 1921

DURING WORLD WAR II, A SCOUT FROM THE ROCKFORD PEACHES OF KENOSHA, WI RECRUITED CLARA TO PITCH FOR THEIR TEAM. THIS TEAM IS DEPICTED IN THE MOVIE "A LEAGUE OF THEIR OWN". CLARA WAS A LEFT HANDED PITCHER AND PLAYED FOR THE ROCKFORD PEACHES (1943), KENOSHA COMETS (1943-1944) AND MILWAUKEE CHICKS (1944). CLARA WAS ONE OF THE 60 FOUNDING MEMBERS OF THE ALL-AMERICAN GIRLS PROFESSIONAL BASEBALL LEAGUE FOR ITS INAUGURAL SEASON IN 1943.

ONE OF SOUTHPORT'S "OWN" CLARA RUTH COOK – CALLED "BABE"

AT THE END OF THE SEASON, COOK RETURNED TO ELMIRA AND TO REMINGTON RAND. SHE WORKED THERE UNTIL 1955, WHEN SPERRY CORPORATION ACQUIRED THE ELMIRA'S PLANT AND RENAMED ITSELF SPERRY RAND. SHE THEN MOVED TO CALIFORNIA AND WORKED AT AN AIRCRAFT COMPANY UNTIL SHE RETIRED. AFTER RETURNING HOME, COOK CONTINUED TO ENCOURAGE AND ORGANIZE TEAMS IN ELMIRA. SHE ALSO HELPED BY COACHING YOUNG WOMEN INTERESTED IN PITCHING.

ON JULY 23, 1996, CLARA COOK DIED IN ELMIRA, NEW YORK, AT THE AGE OF 75. SHE IS BURIED IN THE WEBB MILLS CEMETERY, ALONG WITH HER PARENTS.

PARKS & RECREATION Elmer Goodwi



My name is Ivan Purifoy, Director of Parks and Recreation for the Town of Southport. My third-year anniversary on the job was November 15th, 2024. It has been a joy to be a part of this community and I am looking forward to continuing this career with the Town of Southport. We have so many things happening in our Parks and Recreation Department.

We continue to host annual events, such as the Spring Easter Egg Hunt at Chapel Park, the Autumn Trunk or Treat, or the Winter Christmas Parade and Christmas Land

display. In the Summer, we provide residents with our annual Summer Parks Program, which is a six-week summer program from July-August for 5–12-year-olds. This program runs Monday-Friday from 9am-2:45pm and offers educational, recreational and enrichment opportunities to kids in our community.

Southport Parks are the host to youth sports such as the Cinderella Softball league at Chapel Park, the Southport Recreation Association Boy's lacrosse league at Goodwin Park and currently we are in the preliminary stages of exploring a girl's lacrosse league. We also continue our partnership with Babe Ruth/Cal Ripken Jr. baseball, which is split between Pirozzolo Park and Chapel Park.

Our Town Senior Center continues to be an active center for our residents. The Senior Center operates Monday-Friday at Chapel Park with various groups and activities.

Over the last year we have made numerous improvements to the Town parks. Some of these include: The new pavilion at Draxler Park, resurfacing of the Chapel Park walking path, tennis courts and pickleball courts, solar lighting around the newly resurfaced walking path at Elmer Goodwin Park, and additional cameras throughout our parks. In the future, Parks and Recreation will be looking to make improvements in the 2025 season to our Splash Pad at Elmer Goodwin and adding new outdoor grills to our parks.

ENHANCED STAR

If you are going to be the age 65 anytime during the year 2025 and you are currently receiving the STAR exemption off your school taxes, you may be eligible to apply for the Enhanced STAR if you meet the income standards. You must apply by March 1, 2025. https://www.tax.ny.gov/star/



SENIOR CITIZENS EXEMPTION

Senior exemption (65 and older), with income of \$37,399 or less, will be receiving their renewal application in January 2025. Application and proof of 2023 income must be returned by March 1, 2025.

CODE ENFORCEMENT


GARBAGE

The Town does not have regular garbage pick-up. Residents must hire a local hauler for their household waste. All trash placed at the curb needs to be in suitable containers and the containers may not be placed at the roadside more than 48 hours prior to being picked up. Or you can take your household waste and recycling to the Southport Transfer Station located on Bob Masia Drive. The Drop-off hours are Wednesday 8am to 4pm and Saturday 8am to 12pm.



SIDEWALKS

The Town ordinance §459 requires the maintenance of your sidewalk year-round. Remember to keep the sidewalks free of trip hazards and broken sections as well as free and clear of snow and ice. And please don't throw the snow into the street or roadway.

JUSTICE CORNER

It has been a while since our last newsletter, which was prior to the COVID outbreak and a lot of changes have occurred in the judicial system since then. The State Legislature has made a substantial change to the Criminal Procedure Laws concerning Bail Reform and although it can be complicated, I will try to break it down.

First of all, the new bail reform laws basically breaks crimes down to two categories, qualifying and non-qualifying offenses. Non-qualifying offenses are crimes that bail cannot be set on by the courts and the defendant has to be released on their own recognizances either by appearance ticket or arraignment. This includes most misdemeanor offenses, except domestic related offenses in certain circumstances and non-violent felonies. Qualifying offenses include certain felonies

and domestic misdemeanor charges, where bail can be considered by the court. This has taken a lot of Court's discretion away pertaining to bail.

In other legislation concerning Vehicle and Traffic offenses, a person that does not pay his fine cannot have his license scoffed or suspended for failure to pay a fine, but still can have it suspended for failure to answer a summons. The Court now has to offer a payment plan for paying fines. This Court has always offered such a plan, but now it is mandatory.

Another recent change to the Vehicle and Traffic Law that most drivers are unaware of pertains to license plates. It is illegal to have any type of covering on a license plate, either clear or tinted. This has always been the law but recent legislation has increased the penalty for such violation from a minimum of S25.00 to S100.00 and three or more convictions within a five-year period can result in the suspension of your vehicle's registration.

There have been several other changes to the various laws that we deal with and I will attempt to cover them in upcoming newsletters. These changes have resulted in a substantial increase in our clerical workload and the Town Counsel last year authorized the Court to upgrade our part time clerk to a full-time position which has greatly helped us to keep up with the increased work load. I wish to thank our town board for recognizing this need and responding to our request.
