## LOCAL LAW NO. 1 OF THE YEAR 2017

# AMENDING LOCAL LAW NO. 1 OF THE YEAR 2011, DOG LICENSING LAW OF THE TOWN OF SOUTHPORT

Resolution by: Hurley Seconded by: Szerszen

WHEREAS, the Town Board of the Town of Southport, Chemung County, New York wishes to amend the Town of Southport Municipal Code, Article III, Dog Licensing and Fees, §192-13, Fees, adopted by Local Law No. 1-2011 pursuant to New York State Agriculture & Markets Law Section 110 to provide for a more uniform application of fee collection among residents; and

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Southport, Chemung County, New York wishes to amend Town of Southport Municipal Code, Article III Dog Licensing and Fees, §192-13 Fees, adopted by Local Law No. 1-2011 by removing §192-13 (C); and

BE IT FURTHE RESOLVED, that the Town Board of the Town of Southport, Chemung County, New York proposes to adopt Local Law No. 1 of 2017 as an amendment to the Town of Southport Municipal Code, Article III, Dog Licensing and Fees, § 192-13, Fees, (adopted by Local Law No. 1-2011) which shall read as follows:

# Article III Dog Licensing and Fees

## § 192-13

- A. Fees set forth herein shall be in addition to fees set by the Agriculture and Markets Law of the State of New York and shall be referred to as the "local license fee".
- B. The local license fee for all dogs harbored in the Town of Southport, whether they be neutered or unneutered male dogs, spayed or unspayed female dogs or purebreds, shall be set from time to time by resolution of the Town Board of the Town of Southport at a meeting duly convened of said Town Board.
- C. Guide dogs, service dogs and working dogs shall be exempt from any local license fee.
- D. The fees for redeeming an impounded dog shall be set from time to time by resolution of the Town Board of the Town of Southport at a meeting duly convened of said Town Board. In addition, the owner of any dog so impounded shall be liable for any and all necessary expenses and fees, including but not limited to kennel fees.

AND BE IT FURTHER RESOLVED, that the Town Board of the Town of Southport, Chemung County, New York held a public hearing on Tuesday, April 11, 2017 at 7:15 p.m., at the Town Hall, 1139 Pennsylvania Avenue, Elmira, New York, regarding the adopting of this Local Law contained herein, and

Under Taxpayer's Comments, Laura Moylan from 1165 S. Main Street spoke regarding a rental property at 1161 Charles Street. She stated that since last Fall there have been ongoing issues with the occupants such as letting their dogs run loose in the neighborhood as well as the occupants riding minibikes and 4-wheelers around the house and into the roadway at all hours of the day and night.

George Bullock from 1167 Charles Street stated a dog from the property at 1161 Charles Street attacked his dog today. He called Elmira Animal Control and they responded and gave the occupants at the Charles Street address several violations.

Supervisor Sheen asked Code Enforcement Officer Peter Rocchi if there were any violations at that address and he stated the occupants were just cited with trash and debris and unlicensed vehicles four days ago.

Council Member Szerszen stated that she looked at that property and noticed the trash and debris and unlicensed vehicles.

Supervisor Sheen stated that he will contact the Sheriff's Office and Craig Spencer from Elmira Animal Control and come up with a plan to remedy this situation.

Christina Woodard who also lives at 1167 Charles Street stated that Elmira Animal Control gave the occupants of 1161 Charles Street 11 violations for the incident that took place with her dog.

Brandi Peckham from 1162 S. Main Street states that she lives behind the occupants at 1161 Charles Street and they have broken her fence, thrown garbage over the fence in her yard and she has had to power wash her house and fence several times because the minibikes and 4-wheelers have sprayed mud all over them.

Again, Supervisor Sheen stated he will contact the necessary people and will come up with a solution and will update the residents at the next Town Board Meeting.

Charles Wilson from 399 Widger Hill Road commented on the Shared Service Agreement between Town of Southport Code Enforcement and the City of Elmira, the minutes from February 14, 2017 and January 13, 2017, residency requirements, and ditches on Widger Hill Road.

Barton Graham from 1678 Pennsylvania Avenue commented on correspondence that he sent Supervisor Sheen.

Laura Moylan from 1165 S. Main Street inquired about fixing pot holes on South Main Street.
