Extension of Cell Phone Area Variance Hearing – Horwath Communications

Vice Chairman Faulkner called the meeting to order and asked if anyone was in attendance representing the requested extension. Mr. Dan Schweigard advised he was in attendance as an agent for Verizon. Mr. Arikian recused himself from this hearing.

Mr. Schweigard advised projects have to be prioritized based on the budgeting process and the Bartholomew Road project was bumped down and put on hold for one (1) year, but at this point, the request would be for a one (1) year extension.

Attorney Mauro advised the Board would need to review the requested variance because the variance expired April 19. 2018; The Board would need to go through the process to make sure this is done right because no substantial construction has taken place, need to be sure this is complying with Code, reopen SEQR and issue as a new variance request.

Vice Chairman Faulkner reviewed and completed the SEQR form with Attorney Mauro. The Board discussed the acceptance of the SEQR, Ms. Silvers made a motion to accept the SEQR and request for a new area variance; Ms. Eames seconded that motion, the Board voted unanimously to approve an extension for one (1) year/ Upon further discussion between Mr. Schweigard and Attorney Mauro, Attorney Mauro advised a public hearing should be held because the variance granted previously had expired and the matter before the Board represents a new variance request. Therefore, a public hearing would be required.

The Board unanimously rescinded the extension for one (1) year and voted to hold a public hearing. Vice Chairman Faulkner advised the public hearing would be scheduled for August 15, 2018 at 7:00 pm and paper work would be sent to Horvath Communications by Peter Rocchi, Code Enforcement and Bonnie Balok, ZBA.
