# **7:15 p.m.** – Discussion of 2017 Audit

Supervisor Sheen introduced Patrick Jordan, CPA, Partner of Insero & Co., CPA's, who presented the 2017 audit reports. Mr. Jordan presented an Executive Summary that outlined the 2017 year with a five-year comparison.

Mr. Jordan stated that all financials were in order. Expenses exceeded revenues by \$651,942.00, which was due to the reduction of sales tax by the County to Towns.

The total fund balance is \$2,438,372.00 compared to \$2,915,503 for the year 2016. All of the fund balance is assigned or restricted for the year 2018.

Mr. Jordan made note that revenues need to be addressed as assigned fund balances cannot fund day to day expenses.

Under Taxpayer's Comments, agenda and discussion items only, Supervisor Sheen stated that Discussion item #2 Referral from Town of Southport Planning Board regarding proposed amendment to §525-33 Special Dimensional requirements in the Bulk and Density Control Requirements with the proposed changes, to accept the amendment to the definitions for Agricultural Use in §525-5 and to accept the changes to the Use Regulation Table is still being reviewed by the Planning Boards and will be tabled until the June meeting.

WHEREAS, the Town Board of the Town of Southport per Resolution No. 77-2018, referred to the Town of Southport Planning Board proposed Local Law No. 1 of 2018, a six-month extension to the temporary 12-month Moratorium on solar and wind energy development within the Town of Southport and received a recommendation from the Town Planning Board to approve the proposed local law and for the Town to develop a plan and timeline for the implementation of law for solar and wind energy farms, and

NOW THEREFORE BE IT RESOLVED, that the Town of Southport Town Board accepts the recommendation of the Town of Southport Planning Board, and

BE IT FURTHER RESOLVED, that the Town of Southport Town Board recommends that this proposed Local Law No. 10 fo2018 be referred to the Chemung County Planning Board for review pursuant to General Municipal Law 239-m, and
