LOCAL LAW NO. 1 OF 2018

A SIX-MONTH EXTENSION TO THE TEMPORARY 12-MONTH MORATORIUM ON SOLAR AND WIND ENERGY DEVELOPMENT WITHIN THE TOWN OF SOUTHPORT

WHEREAS, the Town of Southport enacted Local Law No. 2 of 2017 on or about May 9, 2017 to establish a 12-month moratorium in order to allow the Town of Southport to properly plan for any development related to large scale solar energy systems within the Town of Southport, and

WHEREAS, the Town of Southport, as part of its planning in preparation for this potential development in the Town of Southport is reviewing its current zoning laws to address and potential development, and

WHEREAS, Local Law No. 2 of 2017 provided for a temporary 12-month moratorium for any potential development related to any commercial development or installation of solar or wind energy farms as defined herein within the Town of Southport, this proposed Local Law No. 1 of 2018 will provide for a six-month extension of Local Law No. 2 of 2017, and

WHEREAS, the Town of Southport Planning Board and the Chemung County Planning Board have reviewed and approved Local Law No. 1 of 2018, and

NOW THEREFORE BE IT RESOLVED, this proposed Local Law No. 1 of 2018 a six month extension to the temporary 12-month moratorium on solar and wind energy development within the Town of Southport, thereof in its final form having been upon the desks of members of the Board for at least seven (7) calendar days, exclusive of Sunday, prior to this day, and a public hearing having been duly held on June 12, 2018 before the Board upon public notice provided by law, and the said proposed local law having been read in its final form at this meeting, and

BE IT FURTHER RESOLVED, that said proposed Local Law No. 1 of 2018 for the Town of Southport to provide a six (6) month extension to the temporary 12-month moratorium on solar and wind energy development within the Town of Southport, is hereby adopted and enacted, to wit:

Section 1. Title

This local law shall be known as "Local Law No. 1 of the Year 2018, A Six-Month Extension to the Temporary 12-Month Moratorium on Solar and Wind Energy Development within the Town of Southport".

Section 2. Legislative Intent

- A. Local Law No. 2 of 2017 established a 12-month moratorium for any potential development related to any commercial development or installation of solar or wind energy farms as defined herein within the Town of Southport. Pursuant to Local Law No. 2 of 2017, the Town imposed a temporary 12-month moratorium on the issuance of building permits, variances, site plan approvals, or any related review pursuant to a request for such solar or wind energy systems within the Town of Southport.
- B. The purpose of the law is to extend the effective time period for Local Law No. 2 of 2017 to allow the Town additional time to review the zoning laws and to complete the planning process for the Town.
- C. During the period for this extension of the moratorium, the Town Board intends to suspend land use regulations in the Town of Southport which conflicts with the effect and intent of this local law.
- D. The Town Board finds pursuant to 6 NYCRR 617.5 (C), (30) that the adoption of this extension to the moratorium of land development or construction is a Type II action under the New York State Environmental Quality Review Act ("SEQR") which has been determined to not have a significant impact on the environment.

Section 3. Extended Term for Moratorium

- A. Local Law No. 2 of 2017 shall be extended for an additional six (6) months through October 31, 2018.
- B. Except as otherwise amended herein, all provisions of Local Law No. 2 of 2017 shall remain in effect and be extended for an additional six (6) months through October 31, 2018.

<u>Section 4.</u> Authority.

This Moratorium is enacted by the Town Board pursuant to its authority to adopt local laws Under Article IX of the New York State Constitution and Municipal Home Rules Law §10.

<u>Section 5.</u> Supersession of the Town Law.

This local law is hereby adopted pursuant to Municipal Home Rules Law §10. It is the intent of the Town Board, pursuant to Municipal Home Rules Law to supersede the following provisions of the New York State Town Law as it relates to zoning and planning determinations under Town Law § 274-a, § 274-b, § 267-a, § 267-b, § 276, and § 277.

<u>Section 6.</u> Inconsistent Laws.

All laws inconsistent with any provision or provisions of this law are hereby repealed.

<u>Section 7.</u> Severability.

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law, ok the application thereof to any person, firm, or corporation or circumstance, is invalid or unconstitutional, the court's order or judgment shall not affect, impair or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law, or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 8. Effective Date.

This local law shall take effect immediately upon filing with the New York State Secretary of State.

WHEREAS, to provide services in some rural areas additional poles are required to make these services accessible, and

WHEREAS, Time Warner Cable Northeast LLC is requesting that the Town allow additional utility poles be placed in the Town's right of way along Laurel Run Road and Kinner Hill Road in the Town of Southport, and

THEREFORE BE IT RESOLVED, that the Town of Southport Town Board, County of Chemung, State of New York hereby authorizes Time Warner Cable Northeast LLC to place additional utility poles within the Town's right of way along Laurel Run Road and Kinner Hill Road in accordance with the engineer certified map dated May 2018 titled "Charter Communications Laurel Run and Kinner Hill Road" provided by the Time Warner Cable Northeast LLC to allow for the extension of internet services to residents in such rural areas of the Town of Southport, and

BE IT FURTHER RESOLVED, that any maintenance or repair of the poles will be the sole responsibility of Time Warner Cable Northeast LLC.

WHEREAS, the Town of Southport Town Board created a Building Reserve fund in accordance with General Municipal Law Section 6-c to fund future buildings, and

WHEREAS, funds in the Building Reserve Fund are in excess of the needs of the Town for future buildings, and

WHEREAS, due to the increasing need to improve highway infrastructure, the Town wishes to establish a Highway Improvement Reserve Fund and transfer funds from the Building Reserve Fund to the Highway Improvement Reserve Fund, and

THEREFORE BE IT RESOLVED, that the Town of Southport Town Board authorizes the establishment of a "Highway Improvement Reserve Fund" to accumulate funds to finance the cost of highway improvements within the Town pursuant to Section 6-c of the General Municipal Law, and

BE IT FURTHER RESOLVED, that the Town Supervisor is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The Town Supervisor may invest the moneys in the Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the investment policy of the Town of Southport. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue for the Reserve Fund in a manner which maintains the separate identity of the cash and investments of the Reserve Fund, and BE IT FURTHER RESOLVED, that except as provided by Section 6-c of the General Municipal Law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund was established. No expenditure shall be made from this Reserve Fund without approval of the Town Board of the Town of Southport and without such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law, and

THEREFORE BE IT RESOLVED, that the Town of Southport Town Board authorizes the transfer of four hundred thousand dollars (\$400,000.00) from the Building Reserve Fund to the Highway Improvement Reserve Fund in accordance to law and this transfer is subject to a permissive referendum.
