RESOLUTION URGING THE GOVERNOR OF THE STATE OF NEW YORK AND THE NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION TO EXPEDITE THE ELMIRA HIGH SCHOOL BROWNFIELD CLEANUP PROGRAM (Former Sperry Remington-North Portion, NYSDEC Project Number: C808022)

WHEREAS, the Former Sperry Remington Property – North Portion Brownfield Cleanup Program Site #C808022 encompasses thirty-four acres on real property currently owned by the Elmira City School District and houses the currently active Elmira High School, and WHEREAS, following an environmental investigation by the New York State Departments of Health and Environmental Conservation between 2000 and 2003, Unisys, the successor to Sperry Remington, entered into an Order of Consent with New York State in 2014 to conduct more intensive investigations, and

WHEREAS, investigations, testing and cleanup activities have been undertaken and are continuing, children are still attending Elmira High School and teachers, administrators, and support staff are still actively working daily at this BCP site, and

WHEREAS, contaminants including, but not limited to, polychlorinated biphenyls, and volatile organic compounds (including trichloroethylene), have been detected either on the grounds, under or in the building or ground water, and

WHEREAS, the citizens of Chemung County are justifiably concerned about utilizing this property as an active school given the level of cleanup necessary.

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Southport on behalf of the citizens of Chemung County do hereby urge Governor Cuomo and the New York State Department of Environmental Conservation to expedite the Elmira High School Brownfield Cleanup Program, and be it further

RESOLVED, that the Clerk of the Town of Southport is hereby authorized and directed to forward certified copies of this Resolution to the Governor, to the New York State Departments of Health and Environmental Conservation and to the Superintendent of the Elmira City School District.

AUTHORIZING SUPERVISOR TO ENTER INTO AN INTERMUNICIPAL AGREEMENT WITH CHEMUNG COUNTY IN CONJUNCTION WITH THE LELAND STREET AREA SANITARY SEWER DISTRICT EXTENSION

WHEREAS, the Town of Southport wishes to enter into an intermunicipal agreement with the Chemung County Sewer District, an administrative unit of the County of Chemung, to allow for the extension of the sewer district to include the Leland Street Service Area ("District Extension"), and

WHEREAS, the Town received a grant for \$2,031,500 from the New York State Department of Environmental Conservation to assist with the costs incurred with the design and construction of sanitary sewers and related collection facilities to provide for an extension of the Chemung County Sewer District ("Project"), and

WHEREAS the total cost of the Project is projected to be \$2,390,000 and the County of Chemung authorized the issuance of a bond in the amount of \$720,000 to pay for the expenses that do not qualify for payment by the grant, and

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Southport, County of Chemung, State of New York, hereby agrees to enter into an intermunicipal agreement with the Chemung County Sewer District, an administrative unit of the County of Chemung, for the purposes of effectuating the Project for the District Extension as set forth in the agreement and further authorizes the Town Supervisor to execute this intermunicipal agreement, and

BE IT FURTHER RESOLVED, that this intermunicipal agreement is subject to the approval of the Chemung County Sewer District/County of Chemung.
