ADOPTING LOCAL LAW NO. 1 OF 2019 AUTHORIZING THE SALARY OF THE TOWN SUPERVISOR OF THE TOWN OF SOUTHPORT TO BE LESSER THAN THE AMOUNT SPECIFIED IN THE NOTICE OF HEARING ON THE 2019 PRELIMINARY BUDGET FOR THE TOWN OF SOUTHPORT

BE IT ENACTED by the Town Board of the Town of Southport as follows:

Section 1. Purpose

The purpose of this Local Law is to decrease the salary of the Town Supervisor of the Town of Southport from the amount set forth in the Notice of Hearing on the 2019 Town of Southport Preliminary Budget.

Section 2.

Pursuant to Section 27 of the Town Law the 2019 Preliminary Budget for the Town of Southport is hereby amended to decrease the 2019 salary for the Town Supervisor of the Town of Southport from THIRTY-EIGHT THOUSAND TWO HUNDRED TWENTY FOUR DOLLARS (\$38,224.00), this being the amount that appeared in the Notice of Hearing on the 2019 Town of Southport Preliminary Budget, to THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00), an amount less than the specified in said Notice of Hearing.

Section 3.

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed, but only to the extent that they are inconsistent with this Local Law.

Section 4.

This Local Law shall take effect immediately upon its filing in the Office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
