INTERMUNICIPAL AGREEMENT FOR ANIMAL CONTROL SERVICES BETWEEN THE TOWN OF SOUTHPORT AND THE CITY OF ELMIRA

WHEREAS, the City of Elmira has proposed to provide animal control services to the Town of Southport from January 1, 2020 through December 31, 2020 for the total cost of THIRTY-SIX THOUSAND, NINE HUNDRED FORTY DOLLARS AND 00/100 (\$36,940.00) in twelve (12) monthly installments of THREE THOUSAND SEVENTY-EIGHT DOLLARS AND 33/100 (\$3,078.33).

WHEREAS, the City of Elmira has agreed to a road officer available 24 hours a day, seven days a week to the residents of the Town of Southport for animal control services.
