RESOLUTION NO. 143-2020

LOCAL LAW NO. 4 OF 2020 A LOCAL LAW OF THE TOWN OF SOUTHPORT, NEW YORK TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW SECTION 3-C

WHEREAS, the Town of Southport wishes to enact a local law to allow the Town of Southport to override the tax levy limit established in General Municipal Law Section 3-c for the year commencing January 1, 2021.

WHEREAS, this proposed Local Law No. 4 of 2020 to override the tax levy limit established in General Municipal Law Section 3-c, thereof in its final form having been upon the desks of members of the Board for at least seven (7) calendar days, exclusive of Sunday, prior to this day, and a public hearing having been held on October 13, 2020 before the Board upon public notice provided by law, and the said proposed local law having been read in its final form at this meeting.

NOW THEREFORE BE IT RESOLVED, that said proposed Local Law No. 4 of 2020 to override the tax levy limit established in General Municipal Law Section 3-c, is hereby adopted and enacted, to wit:

Section 1: Legislative Intent:

It is the intent of this local law to allow the Town of Southport to adopt a budget for the fiscal year commencing January 1, 2021 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law Section 3-c.

Section 2: Authority

This local law is adopted pursuant to subdivision 5 of the General Municipal Law section 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section 3: Tax Levy Limit Override

The Town Board of the Town of Southport, New York, County of Chemung is hereby authorized to adopt a budget for the fiscal year commencing January 1, 2021 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law Section 3-c.

Section 4: Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law for the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstances, directly involved in the controversy in which such judgment or order shall be rendered.

Section 7: Effective Date

This Local Law shall take effect immediately upon filing with the Secretary of State.

LOCAL LAW NO. 6 OF 2020 TO AMEND ARTICLE VI, WINTER PARKING § 497-19

WHEREAS, the Town of Southport wishes to amend Article VI, Winter Parking to further accommodate the parking concerns of residents while supporting the needs of the highway department for efficient and safe snow and ice removal, and

WHEREAS, Local Law No. 6 of 2020 to Amend Article VI, Winter Parking, § 497-19 Prohibited Winter Parking, thereof in its final form having been upon the desks of members of the Town Board for at least seven (7) calendar days, exclusive of Sunday, prior to this day, and a public hearing having been held on October 13, 2020 at 7:15 p.m. before the Town of Southport Town Board upon public notice provided by law, and the said proposed local law having been read in its final form at this meeting, and

NOW THEREFORE BE IT RESOLVED, the Town Board of the Town of Southport, County of Chemung, State of New York hereby adopts and enacts, Local Law No. 6 of 2020, to Amend Article VI, Winter Parking § 497-19 Prohibited Winter Parking, to wit:

LOCAL LAW NO. 6 OF 2020 TO AMEND ARTICLE VI, WINTER PARKING § 497-19

Section 1.

§ 497-19 Prohibited Winter Parking

In order to expedite the removal of snow and ice and to facilitate the cleaning of Town highways, the parking of motor vehicles shall be prohibited on all streets or a portion thereof within the Town beginning November 1st through April 1st between the hours of 2:00 a.m. and 7:00 a.m., except as follows:

- 1) On days with even numbers according to the calendar, on the side of any street on which the properties bear even street numbers.
- 2) On days with odd numbers according to the calendar, on the side of any street on which the properties bear odd street numbers.

Section II: Severability

The invalidity or unenforceability of any section, paragraph, sentence, clause, provision, or phrase of the aforementioned sections, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability of any other section, subsection, paragraph, sentence, clause, provision, or phrase, which shall remain in full force and effect.

Section III. Repeal Prior Laws

This local law is enacted by the Town Board pursuant to its authority to adopt local laws under Article IX of the New York State Constitution, Municipal Home Rules Law § 10.

Section IV. Authority

This local law is enacted by the Town Board pursuant to its authority to adopt local laws under Article IX of the New York State Constitution, Municipal Home Rules Law § 10 and Town Law § 10.

Section III. Effective Date

This Local Law shall take effect upon adoption, publication and filing in the Office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

RESOLUTION NO. 145-2020

LOCAL LAW NO. 5 OF 2020 COLD WAR VETERANS EXEMPTION

WHEREAS, the Town of Southport wishes to adopt Local Law No. 5 of 2020 to allow a Cold War Veterans Exemption for property taxes in accordance with New York State Real Property Tax Law § 458-b.

NOW THEREFORE BE IT RESOLVED, that the Town of Southport hereby schedules a public hearing for Local Law No. 5 of 2020 on October 13, 2020 at 7:30 p.m., or as soon thereafter as it can be heard, to wit:

LOCAL LAW NO. 5 OF 2020 COLD WAR VETERANS EXEMPTION

Section 1. Purpose.

(a) The purpose of this local law is to authorize a limited exemption from real property taxes for residential real property owned by veterans and their surviving spouses who rendered military service to the United States during the "Cold War" pursuant to Section 458-b of the Real Property Tax Law.

(b) Pursuant to subsection 2 (c)(ii) of § 458-b of the Real Property Tax Law, if a Cold War veteran receives the exemption under § 458 or 458-a of the Real Property Tax Law, the Cold War veteran shall not be eligible for this exemption.

Section 2. Term.

Pursuant to subsection 2 (c)(iii) of § 458-b of the New York State Real Property Tax Law, the exemption authorized shall apply to qualifying owners of qualifying real property for as long as they remain qualifying owners, without regard to a ten-year limitation.

Section 3. Cold War Exemption.

(a) Pursuant to subsection 2 (a) of § 458-b of the Real Property Tax Law of the State of New York, and subject to the definitions, limitations and requirements of said § 458-b, the Town of Southport hereby adopts the qualifying residential real property exemption under subsection 2 (a)(ii) of § 458-b of the Real Property Tax Law of the State of New York, that is, an exemption in the amount of fifteen percent (15%) of the assessed value of such property; provided, however, that such exemption shall not exceed twelve thousand dollars (\$12,000) or the product of twelve thousand dollars multiplied by the latest state equalization rate of such property's assessing unit, or, in the case of a special assessing unit, the latest class ratio, whichever is less.

(b) Pursuant to subsection 2 (b) of § 458-b of the Real Property Tax Law of the State of New York, and subject to the definitions, limitations and requirements of said § 458-b, the Town of Southport hereby adopts the qualifying residential real property exemption under subsection 2 (b) of § 458-b of the Real Property Tax Law of the State of New York. Where the Cold War veteran received a compensation rating from the United States Veterans Affairs or from the United States Department of Defense because of a service-connected disability, qualifying residential real property shall be exempt from taxation to the extent of the product of the assessed value of such property multiplied by fifty percent of the Cold War veteran disability rating; provided, however, that such exemption, as permitted by subsection 2 (c)(iii), shall not exceed forty thousand dollars (\$40,000) or the product of forty thousand dollars multiplied by the latest state equalization rate for the assessing unit, the latest class ratio, whichever is less.

Section 4. Effective Date:

This Local Law shall take effect immediately upon its filing with the Secretary of State and shall be applicable to all assessment rolls prepared pursuant to the first taxable status date occurring on or after the effective date of this Local Law.

WHEREAS, THE Town of Southport wishes to update its fee schedule and policy regarding access to public records and fees for photocopies and scanning for the public requests of records; and

NOW THEREFORE BE IT RESOLVED, that the Town of Southport hereby implements and authorizes the following procedures and fee schedule for the reproduction of records in accordance to the New York Public Officer Law:

- 1. The Town Clerk is designated as the Records Management Officer.
- 2. All requests for records must be directed to the Records Management Officer (Town Clerk).
- 3. Such requests for records may be submitted in person at the Town Clerk's Office during normal business hours by completing and submitting the request form provided by the Clerk.
- 4. Such requests for records may be submitted on-line with the format provided at the Town of Southport's website.
- 5. Twenty-five cents per photocopy not in excess of nine inches by fourteen inches or actual costs of reproducing any other record.
- 6. The actual cost of reproducing the records may include the following:
 - a. The actual cost of storage device or media
 - b. The actual cost to Town of engaging outside professional service to prepare a copy of the record.
 - c. The administrative cost as set forth in Public Officer Law Section 87.
- 7. Upon request the Town will make records available for inspection and copying; however, the Town may deny access to certain records as set forth in the Public Officers Law.
- 8. The Town will inform the person making the request for documents of the estimated cost of preparing copies if more than two hours of a Town employee's time is needed or if an outside professional service would be retained to prepare a copy of the record.
