AN ORDINANCE TO AMEND THE CODE OF THE TOWN OF SOUTHPORT CHAPTER 497, VEHICLE AND TRAFFIC, ARTICLE II, STOP AND YIELD INTERSECTIONS, SECTION 497-5 YIELD INTERSECTIONS, TO REMOVE YIELD SIGN ON HOLECEK AVENUE AT THE EAST ENTRANCE OF HOLECEK AVENUE AT THE INTERSECTION OF CHAMBERLAIN STREET AND HOLECEK AVENUE AND SECTION 497-4 STOP INTERSECTION, TO ERECT STOP SIGNS ON HOLECEK AVENUE AT THE INTERSECTION OF CHAMBERLAIN STREET ON BOTH ENTRANCES OF HOLECEK AVENUE

The Planning Board and/or Town Board may require an applicant for any review, permit or approval to deposit in escrow a sufficient amount to pay for the reasonable and necessary fees and/or costs of any engineer, consultant or attorney designated by the Planning Board and/or Town Board to review such application. The fees and/or costs charged by such engineer, consultant or attorney in connection with such review will be charged against the sum deposited in escrow. Any amount remaining shall be returned to the applicant within 45 days of final action on the application.

BE IT FURTHER RESOLVED, that the Town of Southport hereby refers this proposed amendment set forth herein to the Town of Southport Planning Board for review in accordance with Section 525-148 of the Code of the Town of Southport.
